PROTECTION OF JUVENILES IN JAILS

Chief Justice of Islamabad High Court inspected the Adiyala Jail along with the Chairperson, NCHR to assess the overall human rights situation at Adyala Jail, Rawalpindi. The NCHR team has consistently been visiting the Jail and took note of under trial juveniles at Adiyala jail. Under the JJSA, 2018, the following points need to be checked by the Child Protection & Welfare Bureau for the betterment of under trial juveniles:

- Mechanism of monitoring of children in prison through jail visits and i. collection of information of the pre-sentence and sentenced children.
- Training of prison staff, probation officers, police and magistrates on ii. international standards of juvenile justice as per JJSA 2018.
- Policy and law reform recommendations and advocacy campaigns based on iii. issues identified from information on children in prisons.
- Legal Defence of children in conflict with the law and interviews with child iv. prisoners and their families.
- Legal aid to children in prison. v.
- Education for children in Prison by designing a more dynamic education and vi. awareness program for children.
- Knowledge-based program which may impart social awareness and human vii. rights values to the children.
- The next date of the case is 16-01-2023 in the Islamabad High court, therefore, it is requested to please provide a detailed report to the Commission on the steps and actions taken by Child Protection & Welfare Bureau, Punjab for the under trial juveniles in different jails of the Province under the JJSO, 2018 well before the next hearing of the case, so that report in this regard may be presented before the court.
