

**INQUIRY REPORT OF NCHR ON TORTURE CASES BY FAISALABAD
POLICE DURING 2006-2012.**

National Commission for Human Rights (NCHR) is an independent statutory body of the Government of Pakistan with an overarching mandate to look into matters pertaining to all forms of human rights violations within the territorial jurisdiction of the Islamic Republic of Pakistan by virtue of the National Commission for Human Rights Act of 2012.

2. NCHR under the Chairmanship of Justice @ Ali Nawaz Chowhan (the then Chairperson NCHR) conducted a detailed inquiry on the complaint of Justice Project Pakistan regarding 1424 cases of abuse & torture by Faisalabad Police during the period 2006-2012. Public hearings/proceedings were also conducted at Faisalabad from time to time by the said inquiry Commission. As a result of inquiry, the Commission formulated certain recommendations for implementation by the Home Department and the office of Inspector General of Police Punjab.

3. A copy of the report is being forwarded to delve into the recommendations of this Commission and for sending an implementation report to this office as envisaged under Section 18 (d) of NCHR Act, 2012 within a period of one month.
