



## MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding ("MoU") sets out the terms and understanding between the National Commission for Human Rights KP office and the Blue Veins registered with Social Welfare Department & KP Charity Commission having registration # DSW/NWFP 2028 and KP Charity Commission with its office located at House No 54/A Street 16 Overseas Pakistani Foundation (OPF) Colony Budni Road Peshawar, to collaborate in areas detailed below:

#### A. Background

Both NCHR and Blue Veins recognize that mutual technical cooperation and collaboration is needed to promote human rights agenda and improving the status of vulnerable communities including women & young girls, PWDs, transgender persons and minorities in Khyber Pakhtunkhwa province.

With the overall goal of strengthening cooperation, coordination and collaboration between the NCHR and Blue Veins for enhanced synergies for the protection and promotion of human rights, both NCHR & Blue Veins intend to formalize the mutual collaboration by signing this MoU.

#### **B.** Scope of Cooperation

The scope of cooperation will be spread over the corresponding role of oversight, promoting Human Rights, systems reforms and improv rights of vulnerable communities & Blue Veins agree to do the following:

- i. Develop and review from time to time a calendar of meetings and an action plan for smooth and effective coordination and collaboration in matters relation to human rights.
- ii. Explore opportunities of working together in areas of human rights awareness, capacity development of institutions and legislative reform in areas related to women, girls and transgender persons, PWDs and minorities.

### C. Period of Cooperation

This MoU shall remain in effect from the date of signing of the memorandum till any further notice. Either party may end their participation in the MoU at any time with or without establishing the cause, via (60) days' written notice to the other.

# D. Legal Framework, Financial Implications and Language of Communication

This MoU is a description of the scope of understanding on the aforementioned key areas and is not to create legally binding relations between the parties and shall not create any financial implications for either of the parties. The mode of written communication between two parties at all levels shall be English.
