National Commission for Human Rights (Referred to as "First Party")

And Da Hawwa Lur

(Referred to as "Second Party")

(Jointly referred as "parties")

Background

National Commission for Human Rights (NCHR) and Da Hawa Lur are two independent entities that have shared aims and objectives. The MoU will enable the citizens, particularly the marginalised community (women and transgender), to access the legal justice system, Conflict resolutions and protection.

National Commission for Human Rights hereinafter called the 1st Party of this MoU.

The National Commission for Human Rights was formed through The National Commission of Human Rights Act,2012. The Commission was created for the promotion and protection of human rights according to the Constitution of The Islamic Republic of Pakistan, 1973.



Objectives and Description of Collaborative Relationship and Role.

Both the parties developed this Memorandum of Understanding (MoU) to improve collaboration and to contribute in promoting gender equality, access to justice system, to encourage women and transgender to avail the available opportunities and to create a society where women and transgender can live with equal rights, and dignity. This collaboration identifies the following strategies and the role of both parties in achieving the shared objective of the MoU.

A. First Party:

Administrative support regarding

- a. Providing support in policy advocacy and implementation of prowomen and transgender legislations to promote human rights.
- b. Provide support in the sensitization of Da Hawwa Lur staff and its targeted beneficiaries/communities on Human Rights.
- c. Support the 2nd party in providing protection to the survivors of gender based and sexual violence through the referral pathways.

B. Second Party:

- a. Provide forums to the 1st party to introduce NCHR, aware the communities about its mandate and how to ensure that communities, especially women, benefit from the right to access to justice.
- b. Provide free psychological support services to the survivor of Gender Based Violence (GBV) referred by the first party.
- c. Provide free legal support services to the survivor of GBV referred by the first party.
- d. Provide support in conducting sessions on anti-harassment, domestic violence and Property Rights Laws.

Other (General) Terms and Conditions

- a. Both parties to this MoU shall be exempted from any liability whatsoever in respect of loss and/or death and/or injury and/or damage sustained by any party by any reason whatsoever.
- b. The memorandum may be terminated by either party giving the other party a three months notice in writing



- c. It is agreed by both the parties to nominate focal persons to coordinate and initiate the roles of the parties to be executed accordingly and to develop a joint plan inline with the MoU.
- d. Both parties must obtain formal approval before using each others' logo, name and trademark etc.
- e. In case of any dispute, the two parties shall first try to resolve any controversy or claim arising out of or relating to this MoU, or the breach or alleged breach thereof, by good faith negotiation among senior managers/directors.
- f. Both the parties are liable to maintain the confidentiality of the referred cases, in the cases of violation the other have the legal right to complain to the relevant authorities.
