



Memorandum of Understanding
Between
National Commission for Human Rights, Islamabad
and
Fatima Jinnah Women University Rawalpindi

The National Commission for Human Rights (referred to as NCHR) and Fatima Jinnah Women University Rawalpindi (referred to as FJWU), collectively referred to as "the parties," agree to collaborate in promoting human rights education within FJWU.

Purpose and Scope:

The primary objective of this MoU is to facilitate the propagation of human rights education among the diverse student body across various departments of FJWU. The agreement aims to:

- i. Create awareness and stimulate interest in the field of human rights among students.
- ii. Encourage research, discussions, and activities related to fundamental human rights principles through the academic curriculum.
- iii. Foster an understanding of international human rights laws.
- iv. Support initiatives aimed at empowering marginalized groups through knowledge dissemination on their rights, including women, children, and minorities.
- v. Encourage the establishment of forums, discussions, and activities that contribute to enhancing a culture of human rights awareness within FJWU.

Responsibilities under this MoU:

The parties agree to undertake various collaborative activities:

- i. Organize seminars, talks, and workshops on human rights issues relevant to the academic curriculum.
- ii. Encourage and facilitate essay competitions, debates, and art competitions related to human rights among students.
- iii. Develop and distribute educational materials, pamphlets, and resources within the legal and cultural guidelines for enhancing human rights literacy.
- iv. Any additional activities mutually agreed upon by both parties within the scope of this MoU.

Specific activities based on this MoU will be planned through consultation between NCHR and FJWU representatives.

Each party will designate focal persons to coordinate activities and share financial responsibilities in implementing the activities outlined under this MoU. Except when specified and agreed upon under this MoU, This MoU shall impose no financial obligation on any party.

Both the parties shall safeguard the confidential information of each other and shall use the title/names of each other in advertisements/announcements with mutual consent.

Duration and Termination:

This MoU will be effective upon the signatures of the parties and will remain in force until modified or terminated by mutual agreement.

Either party may terminate this MoU by providing a written notice at least thirty calendar days in advance. Termination shall not affect ongoing activities initiated before the termination date.

Liaison:


NCHR and FJWU will maintain regular communication to ensure effective implementation of the agreed-upon activities.
