2. Whereas the National Commission for Human Rights is an independent Government body tasked to look into matters pertaining to all forms of violations of human rights within the territorial jurisdiction of the Islamic Republic of Pakistan.

3. With the aforementioned in view, I am directed to refer a copy of the complaint filed by Barrister Sarah Belal, Advocate High Court, Justice Project Pakistan, with regards to the above-cited subject-matter.


4. You are hereby requested to provide the complete case files, entire jail medical record and mercy petitions rejected by the President of Pakistan of these 7 prisoners imprisoned in Punjab prisoners:

- i. Muhammad Afzal s/o Muhammad Asghar, currently confined in Central Jail, Gujranwala under FIR No. 1017/2011;
- ii. Muhammad Imran s/o Faqeer Muhammad, currently confined in District Jail Toba Tek Singh under FIR No. 197/2010;
- iii. Muhammad Shaban s/o Muhammad Anwar, currently confined in District Jail, Sheikhpura under FIR No. 190/2003;
- iv. Asghar s/o Muhammad Akram, currently confined in Central jail, Bahawalpur under FIR No. 577/2007;
- v. Akbar s/o Muhammad Akram, currently confined in Central jail, Bahawalpur under FIR No. 577/2007;
- vi. Sharafat Ali s/o Saif Ali, currently confined in Central Jail, Lahore under FIR No. 503/2003;
- vii. Ahmed Ali s/o Ali, currently confined in Central Jail, Sahiwal under FIR No. 47/2009.

5. We request you to stay the executions of all the above-mentioned prisoners till the inquiry is concluded and a detailed report is issued in this matter pursuant to section 9 and all other relevant provisions of the National commission for Human Rights Act, 2012.

6. The National Commission for Human Rights, Pakistan looks forward to your cooperation in this regard.
